



2022 NADL University Grant

Application Deadline: July 15, 2022

BACKGROUND:

The Foundation for Dental Laboratory Technology (Foundation) is a non-profit 501c (3) organization. The purpose of the Foundation is to advance the profession of dental laboratory technology by addressing industry driven needs and providing solutions that are relevant and accessible to dental technicians and other members of the dental team.

GRANT OVERVIEW:

Recognizing the continuous need for dental laboratory management and education, the Foundation is bringing back the NADL University Grant in 2022.

The NADL University Grant will cover tuition for two individuals to attend NADL University (NADL U) in 2022. The cost to attend NADL U would typically be \$1,595 per individual; however, grant recipients will have their tuition fee covered by the Foundation.

NADL U was developed to meet the growing educational needs of today's dental laboratory managers. The program allows eligible professionals to earn a Certificate in Dental Laboratory Management during a three day intensive course of study. REQUIREMENTS:

1. In order to be eligible for this grant, an applicant must be a member of NADL or must be employed by a member of NADL and meet one of the following NADL U criteria:
 - a. Graduated from a dental laboratory technology program and worked in the dental laboratory field for at least one year.
 - b. Worked in the dental laboratory industry for at least three years.
 - c. Worked in a related health care field for at least five years.
2. Sitting members of the NADL Board, NBC Trust, or Foundation Trust are not eligible as individuals to apply for or win grants/scholarships offered through the Foundation.
3. The NADL U Grant recipients must be available September 15-17, 2022. Grant funds must be used for 2022 NADL U and may not be carried forward.
4. The NADL U Grant recipients will be responsible for their own travel and accommodations.
5. The NADL U Grant recipients will be required to provide the Foundation with a headshot and testimonial (web video submission or typed submission on letterhead paper) about receiving the grant, attending the meeting, and how this experience will positively impact his/her DLT career.
6. Funds will be provided directly to NADL and not to the individuals awarded the grant.
7. The NADL U Grant recipients must submit an NADL U application by August 25, 2022.
8. The NADL U Grant recipients will not be eligible to receive this grant two years in a row.
